AMENDMENT to DECLARATION for RYEVIEW CONDOMINIUM

(Pursuant to Article 9-B of the Real Property of the State of New York)

WHEREAS, Exhibit B to the Declaration contained a typographical error as to the percentage of common elements allocated to each of the Units BIC and BID;

NOW THEREFORE, said Declaration is hereby amended to provide that the percentage common element allocated to Unit BIC is 3.86 and that the percentage common element allocated to Unit BID is 3.86.

Attached hereto is a revised Exhibit B containing the corrections.
