2018 OPERATING BUDGET 3% INCREASE IN MAINTENANCE CHARGES

At a meeting of the Tudor Arms Board of Directors held on November 14, the 2018 Operating Budget was approved that increases the monthly maintenance charges by 3% commencing January 1, 2018.

This is the first increase in maintenance charges in more than 3 years. The oil surcharge was reduced in 2015 and permanently eliminated in 2016 so the net effect was your monthly maintenance had been reduced over the past 24 months.

The increase in carrying charges is necessary due to forecasted increases in Real Estate taxes and general operating expenses.

ANNUAL SHAREHOLDERS MEETING

More than 25 shareholders attended the Tudor Arms Annual Shareholders Meeting held on November 21 at Angelina's Restaurant in Tuckahoe.

Besides great food and Holiday Spirit, presentations were given by our accountant and managing agent.

Robert Tejeda, our accountant from the firm of Lawrence Honigman reviewed the Tudor Arms financials for 2016 and 2017 year to date and the 2018 Operating Budget.

Mr. Tejeda reported that Tudors Arms has a very healthy financial position as a result of the mortgage refinance that took place in August of 2015. The new mortgage amount of \$3,150,000 is at 3.82% fixed for the 10 year term. As a result of the refinance, Tudor Arms established a new Reserve Fund that financed the recent major capital improvements to the courtyard and garage without the need to impose a special assessment on the shareholders. Tudor Arms spent close to \$500,000 in 2017 and still has a Reserve Fund of \$525,000.

Robert Orlofsky, the managing agent, reviewed general building operation and reported on the garage and courtyard restoration project and renovation of the exercise room.

The courtyard reconstruction that started in April has been completed. It was a very difficult job and we thank the residents who put up with the construction noise and inconvenience while work proceeded.

While the courtyard work moved forward, the Board approved renovation of the interior garage with new energy efficient LED lighting and complete painting which has been a major improvement.

FUTURE CAPITAL PROJECTS

After a very busy 2017, there are no major capital improvements scheduled for next year. However, some improvements being considered for the future include roof replacement, window replacement, ongoing maintenance, repairs of the exterior stucco and brickwork of the building.

SERVICE ANIMAL POLICY

In accordance with the American Disabilities' Act and upon advice from the Tudor Arms attorney, Ronald Sher from the law firm of Himmelfarb and Sher, Tudor Arms adopted a service animal policy. The policy provides that a resident may acquire a dog or other service animal if there is a documented medical need.

The policy has many safeguards regarding the breed of the dog, documentation that verifies the dog has been trained as an emotional support animal and other safe guards that would avoid any damage to the building or excessive barking.

The Tudor Arms Board recently approved a request from a shareholder for an emotional support animal.
